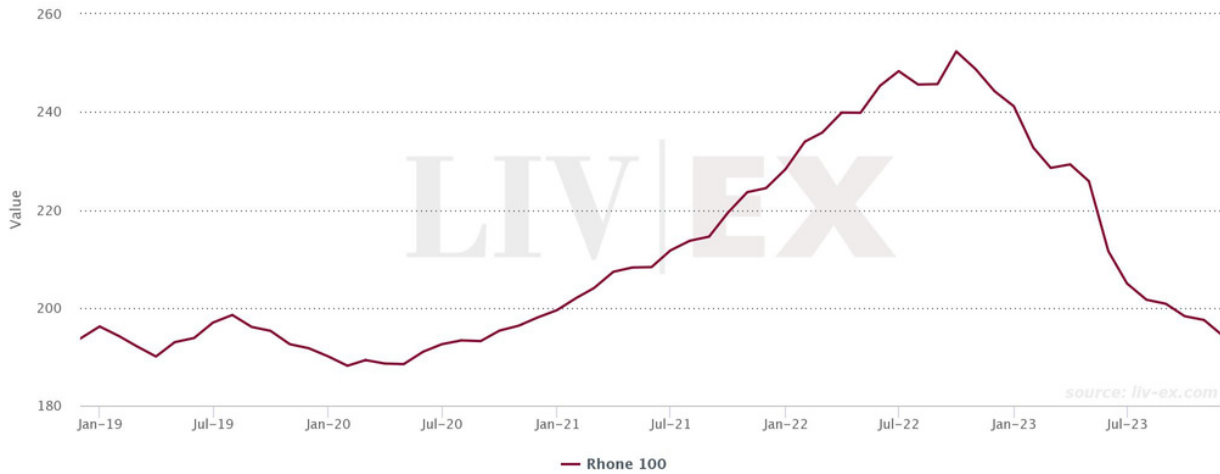
Chateauneuf-du-Pape History & Brand Power

2-Year Chart (November 2021 - November 2023)

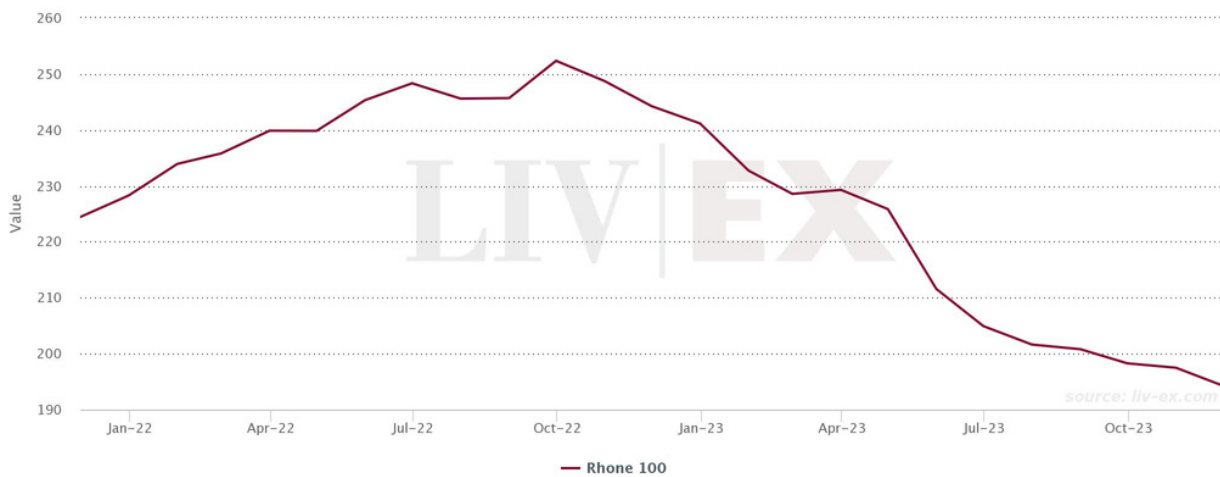
