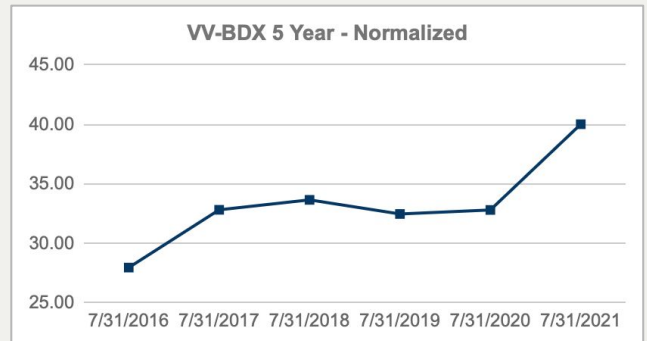

Vint Thesis

Blue Chip Bordeaux wines are considered among the most desirable investment wines on the market, with the best vintages historically driving strong returns. This collection includes wines from the famed 1996 and 1998 vintages in Bordeaux featuring two 100 point scores and two 99 point scores from Bordeaux oracle, Robert Parker. The four wines in this collection are included in Liv-Ex's

Bordeaux Legends 40 Index, which has outperformed the base Bordeaux 500 Index in recent years. Additionally, at 23 and 25 years of age, these wines are just now reaching an acceptable age for drinking. This age is noteworthy because, historically, as wines are consumed, the pace of supply depletion picks up, and the value of the remaining wines increases.

Investment Highlights

KEY POINT #1:

Top Vintages = Top Value

Bordeaux wine quality and subsequent values are vintage dependent, with top years garnering multiples of lesser years. This is abundantly evident with the current value of the wines in this collection on Liv-Ex being 55% higher than the **same** wines from the **same** Chateaux from the less lauded 1997 vintage.

KEY POINT #2:

Top Robert Parker Scores

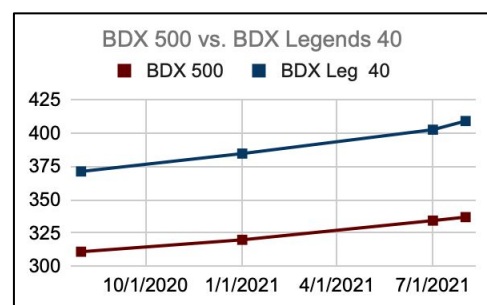
Robert Parker's Bordeaux scores have long been viewed as the gold standard for the region. Wines that are able to get 100 or 99 points from RP have historically seen higher liquidity and higher values in the market.

KEY POINT #3:

Best of Bordeaux

All four wines are listed in Liv-Ex's Bordeaux Legends 40, which is a list of 40 Bordeaux wines from exceptional older vintages (from 1989). The Bordeaux Legends 40 has seen 9.25% growth in the last year compared to 7.7% for the Bordeaux 500.
